You are invited to apply for participation in a Fine Art and CRAFT Fest sponsored by the Catawba River Artisans. This event will be held on the grounds of the Lakewood Professional Park at 5803 Wilkinson Blvd., in Belmont, NC. This is a juried, outdoor show. All art must be original and the creation of the exhibitor. No kits, items from kits, imports, or arts and crafts supplies may be shown or sold. The festival will be held rain or shine, no refunds will be given due to inclement weather. The Catawba River Artisans reserves the right to deny any application.

All booth spaces are 10x10. Vendors are responsible for providing tents, tables, and chairs. The displays must be professional in appearance and tents must be weighted down, no stakes allowed. Electricity is not available. NC sales tax collection as well as remittance to the state is the responsibility of each vendor.

Upon arrival, you are asked to unload and move vehicles to the designated parking area before setting up. All vehicles must be removed from the show area no later than 9:00 a.m. Vendors agree to remain fully set up until 4 p.m. Vendors are responsible for removing any trash in their assigned area and should leave premises in the same condition as when they arrived.

There will be an early event fee of \$50 for all applications received by September 1. The event fee for all applications received after September 1 will be \$60. In addition, if you are a first time vendor to a CRA event, please provide a web address showing examples of your current artwork and/or booth display, or in lieu of the web address, you may include photos with your application. It is to your advantage to apply early as space for this show is very limited.

You will be notified by email as soon as possible after receipt of your application regarding your acceptance into the show. You will be provided with directions to the event, your assigned location on the site, and any other information deemed necessary at least 1 week prior to Oct. 6. Fees will be refunded to any artists not accepted. **Checks should be made payable to: Catawba River Artisans (CRA).** A \$25 fee will be charged for any returned checks.
